Within the framework of the event, a call will be published to reach a diverse group of people who can continuously participate in the process. The Alte Münze represents a great opportunity for Berlin to develop a unique, lively and diverse cultural location. We are dependent on your support and ideas. We would therefore like to ask you to take part in the application process for the workshops.
